- 1. IT IS ESSENTIAL THAT ALL WRITTEN PARTICULARS SHOULD BE READ CAREFULLY BY THE HIRER, SINCE THIS DELIVERY NOTE, ONCE RECEIVED BY OR ON BEHALF OF THE HIRER, REPRESENTS FORMAL ACCEPTANCE OF THE SKIP IN SUITABLE CONDITION. ANY COMPLAINT MUST BE MADE TO THE DRIVER OF THE VEHICLE DELIVERING THE SKIP, AND BE CONFIRMED IN WRITING IMMEDIATELY. ANY SUBSEQUENT COMPLAINTS CANNOT BE ACCEPTED.
- 2. THE SKIP IS NOT TO BE MOVED FROM THE POSITION IN WHICH IT IS PLACED ON DELIVERY TO THE SITE/ADDRESS
- 3. THE SKIP MUST NOT BE LOADED WITH ANY OF THE FOLLOWING ITEMS: FRIDGES OR FREEZERS, TYRES, LIQUID WASTE, WASTE OILS, GAS BOTTLES, FLUORESCENT TUBES, ASBESTOS, FOOD WASTE, DAIRY PRODUCTS, PAINT TINS, TOXIC WASTE, CHEMICALS, PLASTERBOARD, OR ANY HAZARDOUS MATERIAL WHICH REQUIRES A LICENCE FOR DISPOSAL UNDER THE CONTROL OF POLLUTION ACT 1977, AND ANY SUBSEQUENT AMENDMENTS.
- 4. THE SKIP MUST NOT BE LOADED WITH ANY ITEMS WHICH ARE, OR MAY BE DANGEROUS TO ANY PERSON, WHICH REQUIRES A LICENCE FOR DISPOSAL UNDER THE CONTROL OF POLLUTION ACT 1977, AND ANY SUCH AMENDMENTS.
- 5. ANY UNAUTHORISED WASTE (E.G. PLASTERBOARD, ASBESTOS, FRIDGES, AS PER ABOVE) FOUND IN THE SKIPS WILL BE RETURNED TO THE HIRER. THE ENVIRONMENT AGENCY WILL BE NOTIFIED, UNDER THE ENVIRONMENTAL PROTECTION ACT 1990, OF THIS ACTION.
- 6. THE MARKINGS ON THE SKIP, INCLUDING THE REFLECTOR SIGNS AND ANY LIGHTS, ARE NOT TO BE DEFACED, REMOVED OR INTERFERED WITH IN ANY WAY.
- 7. THE SKIP SHALL REMAIN THE PROPERTY OF WORLDCARE (WALES) LTD, AND THEY, AND ANY PERSON AUTHORISED BY THEM, SHALL BE PERMITTED AT ALL REASONABLE TIMES TO ENTER THE PREMISES ON WHICH THE SKIP IS SITUATED, FOR THE PURPOSE OF INSPECTING OR EXAMINING THE SKIP AND ITS CONTENTS. THE HIRER MUST NOT UNDULY WITHOLD ACCESS TO THE SKIP.
- 8. THE HIRER MUST ACCEPT ALL RESPONSIBILITY FOR ANY LOSS OR DAMAGE TO THE SKIP, AND PAY ANY COSTS INCURRED IN REPAIRING OR REPLACING THE SKIP.
- 9. THE HIRER MUST ACCEPT FULL RESPONSIBILITY FOR ANY DAMAGE WHICH MAY OCCUR TO PATHS, DRIVEWAYS ETC. AFTER THE DELIVERY VEHICLE HAS LEFT THE PUBLIC HIGHWAY TO DISCHARGE OR COLLECT SKIPS AND MATERIAL AT THE REQUESTED ADDRESS/SITE.
- 10. ALL SKIP CONTENTS WILL REMAIN THE PROPERTY OF THE HIRER UNTIL PAYMENT IS RECEIVED IN FULL/CLEARED FUNDS.
- 11. WORLDCARE (WALES) LTD RESERVES THE RIGHT TO RETURN ANY WASTE COLLECTED UNTIL WE ARE SATISFIED THAT PAYMENT HAS BEEN MADE IN FULL.
- 12. THE PERIOD OF HIRE, INCLUDED IN THE HIRE CHARGE PER SKIP, IS A MAXIMUM OF 28 DAYS UNLESS OTHERWISE AGREED VERBALLY OR IN WRITING.
